 - Letters of support from Chief and Counsel housing portfolio representatives
 - Letters of support from EIA or CFS workers

Kinew Housing <u>does not</u> have emergency housing.

If you need to update the information contained in your application, send it to us in writing or by email. Updates will not be done over the phone.

Completed applications will only be kept on file for a period of one year after it has been processed.

Incomplete applications will be kept for only one month.
